### 1. Chairman's welcome & Apologies

### 3. Minutes of the meeting held on 10/05/22

### 4. Matters arising directly from the minutes

<u>Playground Equipment</u> – 3 Quotes for Playground Equipment to be provided with CIL funding have been received and will be sent to Councillors with an analysis of relative value for money.

Mirror opposite Village Hall Exit – The mirror and post have been received and can now be installed.

Speed Monitors – These have been received and will be installed once the posts have been positioned.

Drainage/Flooding, Nedging Road – A consultation meeting will take place on 24<sup>th</sup> June with Nedging Road Residents and SCC Floods Team. A Land Drainage mandatory survey (desktop) carried out by SCC Floods Team, would be a first necessary step in the process at a cost of £50 for each resident. A proposal that the Parish Council could pay this initial fee, will be considered when more information has been received after the meeting on 24<sup>th</sup> June. It was noted that the payments are unlikely to be admissible from CIL funds.
